Seedings will be from slow to fast regardless of age and gender. Entries with no seed times will be placed in the slowest heat. Heat sheets will be posted 15 minutes prior to the start of the meet. Separate results and scoring for men and women by age group will be posted after each event.

**Directions:** Follow US Rt 3 to Bar Harbor. At traffic signal, take a left onto Mt Desert St. At next stop sign, take a right onto Maine St and follow for 0.3mi. Turn right on Park St. YMCA is on the right, across from ball fields.

**Facility:** 6-lane pool, will use lanes 1-5 for competition with lane 6 available for continuous warm-up/warm-down. Colorado Timing will be used.
